Hands-on Sustainability Education Program: 45 student groups came to TLC Farm for field trips, ranging from pre-school through adult continuing education, participated in farm tours and a variety of interactive sustainable-living programs. Approximately 500 participants. Community Workshops: Hosted 15 workshops, including Natural Building, Herbal Medicine, Food Preservation, Natural Crafts, Animal Husbandry, Plants & Mushrooms, Applied Permaculture, School Gardens, and Community Process. Permaculture Design Certification Courses: Hosted a two-week residential course in which 15 people received Permaculture Design Certificates. Mother Earth School: Includes the Mother Earth Kindergarten -- the country's first bio-immersion kindergarten -- the Faery Garden pre-school, and a summer camp program. In 2010, 25 students participated in the kindergarten and preschool, and over 50 students attended the summer camp. MES also offered Rite of Passage camps for 9 adolescent boys and girls. In 2010, the Mother Earth School began exploring the possibility of acquiring land near TLC Farm to expand the programs. That exploration is ongoing. Interns & work-trade: 10 interns stayed at TLC Farm, from two weeks to three months, participating in a wide variety of projects, including curriculum development and teaching, gardening and animal husbandry, community outreach, and

4b (Code:) (Expenses \$ 9,102 including grants of \$ 0) (Revenue \$ 7,072)

Demonstration Program. Organic Garden & Food Forest: Converted another .5 acres of lawn and field to organic garden (for a total of 2.5 acres). Maintined these educational gardens and our two Food Forests (multi-level perennial food production systems that mimic the production of a natural ecosystem). Animal Husbandry: TLC Farm is one of the only educational urban farms in the Portland area to provide access to a dairy goat herd. The goats provide city dwellers a rare opportunity to visit with and learn about traditional farm animal; the goats also remove invasive species by browsing blackberries. We were honored to witness the birth of 5 healthy baby goats in 2010, two of which were kept to grow the herd. A rotating chicken flock and sheep herd keep the blackberries from returning, and provide eggs & wool. ReCode: ReCode volunteers helped craft the state's Graywater Use Rules, and began an Ecological Sanitation campaign to create better state code for composting toilets.

Community Capacity Building program. We share this land and our experience with others to cross-pollinate between people and groups, build the sustainability movement, and offer an accessible and inspiring place for groups to use for their own gatherings. Forum: We have made this unique place available to a broad diversity of people to use for their meetings, parties and events. A sample of groups include: The Native American Youth Association using the sweatlodge; Lewis & Clark College Departments holding planning meetings; Wisdom of the Elders running its Peace Warriors groups; meditation groups coming here for retreat; Birthdays and Anniversaries being celebrated in the Village Green; and much more. Community Service Projects: TLC Farm hosted several volunteer service projects, ranging from a group of 200 Whole Foods employees to small Americorps service teams to school groups. Service project participants have assisted with the removal of invasive species, habitat restoration and work in the organic garden. Events: TLC Farm hosted three large interactive celebrations in 2010: Bloom, the Harvest Festival and our Holiday Open House. These large and lively gatherings weave together music, art, education, food and family fun for hundreds of participants.
